Weight, 123 lbs. Non-winners of a graded sweepstakes over nine furlongs on the turf since January 1, allowed 3 lbs. \$60,000 over Nine furlongs on the turf in 2024, 5 lbs. The maximum number of starters will be determined at the time of entry dependent on rail placement. In the event this race overfills preference will be given to graded stakes winners (in order I-II-III), then highest 2023-2024 earnings. Trophy to the winning owner.
