Sign up for tattooing at the Churchill Downs racing office-list the horse's name, barn number, your name, and phone number. The TRPB Technician will scan the microchip to access the digital copy of the foal certificate, validate the information, verify the markings, color and gender, then take 10 -14 photos of the horse to digitally document all equine attributes. Bandages, poultice, blankets must be removed, and the horse must be named by the time the TRPB Technician is present to certify its identity. The Digital Tattoo-fee is \$106 which MUST be paid prior to the TRPB Technician performing the work. Payment can be made by Credit Card, Apple Pay or Google Pay. If arrangements are made with the Churchill Downs bookkeeper's office to provide a bookkeeper's check made out to TRPB in the appropriate amount, this check must be turned over to the Technician at the time of certification.
