

FOR THRE YEAR OLDS AND UPWARD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$2,250 each at time of closing. \$1,125 to pass the entry box; \$1,125 additional to start, with \$225,000 guaranteed plus an additional \$25,000 KTDF for KTDF eligible horses. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights: Older 125 lbs. Three Year Olds, 122 lbs. Non-winners of a Grade I or II stakes since October 28, allowed 2 lbs.; a graded sweepstakes in 2024, 4 lbs. The maximum number of starters for the Kelly's Landing will be limited to fourteen (14). If more than fourteen (14) entries pass the entry box, the starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest 2023-2024 earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box at the usual time of closing. All supplementary nominations will be required to pay entry and starting fees if they participate. Trophy to winning owner.
